Temple School: Every 2nd and 4th Friday of the month from 6:00 pm - 8:00 pm. This program is open to all the kids 5 year and older, at no charge. Please visit temple web site for more details.

India Day: Organized once every year, normally during fall. This is a half day event which is celebrated with Indian classical dances, music, food etc.... Please watch temple web site for details.

UTSAV: UTSAV is an event recently started to celebrate the spirit of India in a fair like environment, organized at the temple premises. This event has a different theme every year like festivals of India. The event also includes great food from various part of India. Please watch temple web site for details.

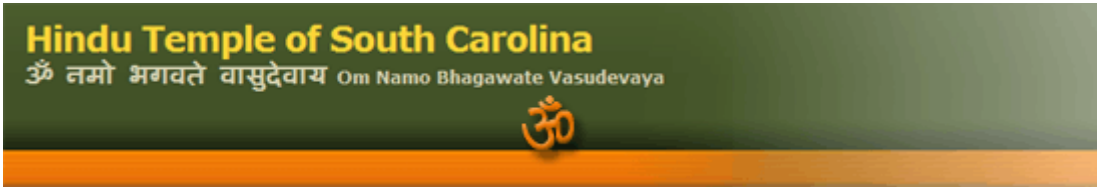

- ॐ Help pay Mortgage installments. Temple currently has loan, which was used for the expansion of the building. The monthly mortgage payment is about \$5,000.00. You can help by paying one or more mortgage payments.
- ॐ Support future building plans. Temple has phase 2 plans to expand the main temple hall so that the larger crowds can be accommodated during main functions.

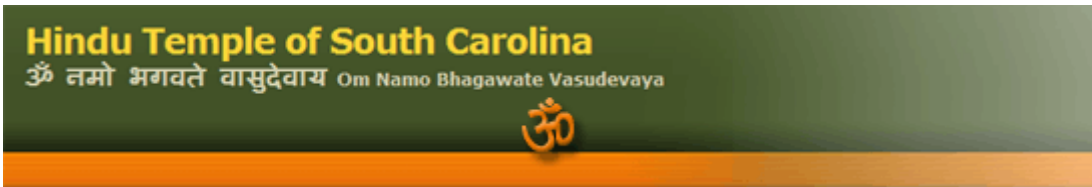
